Florida Statute Section 1003.02 (1)(j) requires district school boards to notify parents of students who earn an industry certification that articulates for postsecondary credit of the estimated cost savings to the parent before the student's high school graduation versus the cost of acquiring such certification after high school graduation, which would include the tuition and fees associated with available post-secondary credits.

The following table contains a list of the certifications offered through Franklin County Schools' career & technical education programs that are eligible for the articulation to a post-secondary program in the State of Florida. The table shows the certification available, the number of credit hours that may be earned, the Associate Degree title, and the estimated college cost savings.

In addition to the certifications that articulate to college credit, Franklin County School's Welding Technology program has a dual enrollment agreement with Lively Technical College. Students in the Welding Technology dual enrollment classes may earn up to 300 clock hours in Lively Technical College's Welding program for an estimated cost savings of \$876 (calculated at \$2.92 per clock hour).
